Dear Cllr Hayday. I'll be completely honest, this is news to me. Junction 4, Handy Cross, has always to my knowledge been the responsibility of the Highway Agency. WDC/CDC have not cleansed or picked the roundabout at junction 4, certainly not during my time with the authority. Such an undertaking would require specialised resource and expertise.

We are responsible for the A404 as far as the border with RBWM. The first 100m on either carriageway is the responsibility of the HA, being an extension of the motorway. We are due a bi-annual pick again soon.

Perhaps colleagues at Highways England could clarify please.
